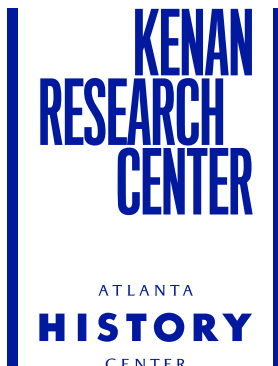

## 2

One copy of the work incorporating the item(s) must be submitted to the Kenan Research Center in a timely fashion and free of charge. Books will be submitted in hardbound editions if available; broadcasts and video sales will be submitted in DVD, and advertising and Web sites using Kenan Research Center materials will provide digital copies of graphics.

## 3

The credit line for each image must read: Kenan Research Center at the Atlanta History Center. When the image is from a photographer's collection, the name of the photographer must be included with the credit line. Website use will include the credit line within the image. Film and video documentary credits may be consolidated at the end of the production.

## 4

Notify Kenan Research Center in writing before the item(s) is/are used in an application other than that specified in this agreement. A new agreement is required and additional image use fees may be required.

## 5

Images must be reproduced in their entirety and without alteration, including cropping, overlapping, overprinting or changes in color, unless written permission from the Kenan Research Center is obtained prior to making any modification of the image. Altered images or details must be labeled as such.

## 6

Permission is only valid for the individual, company, or institution to which it is specifically issued and may not be transferred, assigned, sold, or otherwise disposed of.

## 7

Where copyright is held by a third party, written permission must be secured by the applicant from that party or their agent and must accompany this agreement. The Kenan Research Center assumes no responsibility for royalties or fees claimed by the creator or on the creator's behalf.

## 8

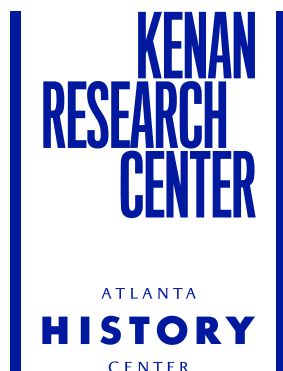

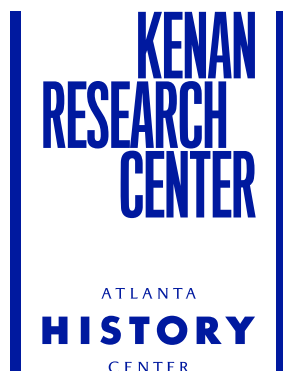
